It is important that the Parish Council's views are made as the high target for new builds in Dorset are very high and building in surrounding villages will affect the infrastructure of the smaller villages. Cllr Jespersen is hosting a multi parish meeting on 11th September 6pm Stourpaine Village Hall about the consultation.
